

## 2. European Social Fund

**The ESF is Europe's main instrument for supporting jobs, helping people get better jobs and ensuring fairer job opportunities for all EU citizens.**

- supporting the adaptability of workers with new skills, and enterprises with new ways of working.
  - focus on improving access to employment: by helping young people make the transition from school to work, or training less-skilled job-seekers to improve their job prospects.
  - vocational training and lifelong learning opportunities to give people new skills form a large part of many ESF projects.
  - helping people from disadvantaged groups to get jobs.

## 2. European Social Fund

- Organizations interested in ESF funding for a project should contact the ESF Managing Authority in their country or region.
  - ESF projects are applied for and run by a wide variety of organizations known as **beneficiaries**, including public administrations, workers' and employers' organisations, NGOs, charities and companies.

## 3. INTERREG EUROPE FUND

Interreg Europe helps regional and local governments across Europe to develop and deliver better policy.

Any actions developed must fall into one of the following four categories:

- Research and innovation
  - SME competitiveness
  - Low-carbon economy
  - Environment and resource efficiency

## 3. INTERREG EUROPE FUND

### three types of beneficiaries:

- **Public authorities** – local, regional and national
  - **Managing authorities/intermediate bodies** - in charge of the Investment for Growth and Jobs programmes or European Territorial Cooperation
  - **Agencies, research institutes, thematic and non-profit organisations**, organisations that work with Interreg Europe must also be based in one the 28 EU Member States, Switzerland or Norway
